### **Coffeehouse, Ice Cream Store and Real Estate Firm Join Waverly** *Public plaza now open at south Charlotte mixed-use community*

**Charlotte, N.C., Sept. 19, 2017** — An independent coffeehouse, a Häagen-Dazs ice cream store and a residential real estate agency will join the tenant mix at the 90-acre Waverly community at the intersection of Providence and Ardrey Kell roads in south Charlotte.

Café Moka, Häagen-Dazs and HM Properties have signed leases at Waverly, which is being developed by Crosland Southeast, Childress Klein and the B. Frank Matthews II family. Café Moka and Häagen-Dazs will be located on The Terrace, a public plaza with outdoor dining space that opened at Waverly with live music and family-friendly entertainment late last month.

“We wanted The Terrace at Waverly to be a place where people would gather and stay a while,” said Peter Pappas, managing partner at Crosland Southeast. “Attracting fun, leisurely tenants like Café Moka and Häagen-Dazs and providing entertainment and interactive fountains helps create that place.”

[Café Moka](#) (1,358 square feet) is an independent coffeehouse that serves high-quality espresso drinks and hand-brewed coffee, partnering with a select group of small-batch, artisan roasters from around the country. Owned by brothers Roark, Rowman and Rhett Basham, Café Moka opened its first location in Virginia Beach in 2010 and expects to open its Waverly store next to Via Roma in December.

[Häagen-Dazs](#) (1,200 square feet), the original super-premium brand, was founded in 1960 on a passion for transforming simple flavors and the finest ingredients possible into an

extraordinary ice cream experience. Today, Häagen-Dazs offers ice cream and sorbet in more than 65 flavors available around the globe for ice cream lovers to enjoy. Owned by Greg and Peggy Jones, the Häagen-Dazs shop will be located in a standalone building on The Terrace and is expected to open in December.

[HM Properties](#) (2,264 square feet) is an award-winning, full-service residential real estate company serving the Charlotte region. Founded in 2006 as an independent, boutique real estate agency, HM Properties has built a reputation as an industry leader and has some of the highest performing brokers in the region. The Waverly office will be the second for HM Properties, which currently has 73 brokers and eight staff members at its SouthPark office. ### **Development Update**

Whole Foods Market, Waverly's retail anchor, celebrated its grand opening in May. Mainstream Boutique and Modern Salon & Spa opened in August, and Scout and Molly's Boutique opened last week.

Waverly's medical office anchor, Novant Health, opened last fall, a six-story office building called The Hub is now completed, and a 141-room Hilton Garden Inn is under construction. The community's parking garage is now open, and a public plaza with outdoor dining space called The Terrace opened in August and will feature live music on weekends through the end of September.

With more than 45 retail shops and restaurants plus a variety of homes and apartments, Waverly will combine a light, contemporary architecture with traditional placemaking in south Charlotte. Retailers now open at Waverly include Chick-fil-A, Chipotle, Chuy's, CycleBar, CVS, District 5 Interiors, Firehouse Subs, Hand & Stone Massage and Facial Spa,

Little Nest Portraits, Mainstream Boutique, Mattress Firm, McDonald's, Modern Salon & Spa, Panera Bread, PetPeople, The Porter's House, Scout and Molly's Boutique, Starbucks, Taziki's, Ted's Montana Grill, Truliant Credit Union, ULTA Beauty, Urbane South, Wells Fargo and Whole Foods.

Waverly is located on the site of the former Matthews Family Farm. The Matthews family personally chose partners Childress Klein and Crosland Southeast to develop the land. The property has been in the Matthews family since 1860 when it was gifted to Sarah Houston by her parents as a wedding present upon her marriage to William McGill Matthews.
